

## Course Descriptions

### EPA Authorized Training Courses

**EPA Renovation, Repair & Painting (RRP)/Certified Renovator Initial Training (1 day course):** This EPA/HUD course trains individuals on how to become Certified Lead-Based Paint Renovators with proper lead safe work practices. This course applies to those who work for compensation on pre-1978 residential properties, child occupied facilities or schools including, but not necessarily limited to painter, plumbers, electricians, handymen/handywomen, carpenters, renovation contactors, maintenance persons at schools or multi-housing facilities, etc. **Cost: \$195.00**

**EPA Renovation, Repair & Painting (RRPR)/Certified Renovator Refresher Training:** This four hour refresher course is required for renewal of the EPA Certified Renovator certification. **Cost \$125.00**

### Minnesota Department of Health Authorized Training Courses

**Lead Abatement for Supervisors Initial Training (4 day course):** The purpose of this course is to train individuals supervising residential lead abatement projects concerning safe effective abatement methods and procedures in addition to the techniques for carrying out lead-based paint, soil and lead dust hazard control activities. **Cost \$695.00**

**Lead Abatement for Supervisors Refresher Training (1 day course):** Review of the above for renewal of Lead Abatement Supervisor licensure. **Cost \$185.00**

**Lead Abatement for Workers Initial Training (2 day course):** The purpose of this course is to train workers in the critical aspects of successfully conducting lead hazard reduction work. **Cost \$295.00**

**Lead Abatement for Workers Refresher Training (1 day course):** Review of the above for renewal of Lead Abatement for Workers licensure. **Cost \$185.00**

**Lead-Based Paint Inspector Initial Training (3 day course):** The purpose of this course is to train lead inspectors in the critical aspects of successfully conducting a lead-based paint inspection. **\$510.00\***

**Lead Risk Assessor Initial Training (2 day course with the Lead-Based Paint Inspector course as a prerequisite):** The purpose of this course is to train risk assessors in the critical aspects of successfully conducting lead hazard risk assessments. **Cost \$360.00**

**\*There is a \$50.00 discount if the Lead-Based Paint Inspector & Lead Risk Assessor Training are taken in the same week. The total of both courses taken in the same week is \$820.00**

**Lead Risk Assessor Refresher Training (1 day course):** Review of the above for renewal of the Lead Risk Assessor licensure. **Cost \$185.00**

**Lead Project Designer Initial Training (1 day course):** The purpose of this course is to train project designers in the critical aspects of successfully designing a lead hazard reduction project. (Note: the Lead

Abatement for Supervisors Initial training is a prerequisite for this course and the Lead Risk Assessor Initial Training is also recommended. **Cost \$350.00**

**Lead Project Designer Refresher Training (1/2 day course):** Review of the above for renewal of the Lead Project Designer licensure. **Cost \$210.00**
